Outreach / **Detached:** Youth workout in the community e.g. streetwork

Outdoors e.g. BBQ's, Game Sessions etc: Will take place in various venues within Garelochhead. If the session is outwith Garelochhead a separate consent will be required.

Closed sessions: Doors close 15 mins after session starts. We request the young person stays for the duration of the session. If a young person chooses to leave during the session we cannot stop them from doing so and are no longer responsible for them.

Drop-in Sessions: Based in The Hub. Young people are free to come and go from the session at any time.. These are not 'closed' sessions and parents/guardians should be aware of this.
